Care and Cleaning

Wash: Machine washable up to 50°C. Larger dirt particles can be scrubbed with a soft bristle brush with water and detergent.

Dry: Wipe with a dry cloth or leave to dry at room temperature, in the shade and away from heat sources. Never dry directly in the sun as heat damages the material, colour and texture.

A soft cloth is the main ally of this type of shoe and its cleaning should be done weekly or whenever necessary.

Attention

SECURLITE will withstand several washes at 50°C in the washing machine. The use of bleaching agents during 50°C machine wash cycles is not recommended.
